**Age Groups:** 18 - 24, 25 - 29, 30 - 34, 35 - 39, 40 - 44, ... in five year increments as high as needed.

**Deadline:** **Individual Event Entries MUST BE RECEIVED by April 10<sup>th</sup> 2015**

**USMS Rules:** USMS Rules govern the meet. The meet is "recognized" meaning participants are not required to be members of USMS to attend. Officials are certified. Failure to act in a sportsmanlike or safe manner or to cooperate with the officials can result in disqualification from the meet. Conduct of this meet shall conform to the relevant USMS swimming rules and administrative regulations. A rulebook will be available. The length of the competition course without a bulkhead is in compliance and on file with USMS in accordance with USMS Rule Book articles 105.1.7 and 107.2.1. Hy-Tek Meet Management will be used with electronic timers and backup watches.

**Directions:** From the 5 North/South, exit Lomas Santa Fe Dr and head west, towards the ocean. Pool will be on the south side of Lomas Santa Fe about a mile west of the freeway.

**Pool Details:** The pool is a 25 yard outdoor, 10 lane competition pool, with a 6 lane, 25 yard pool for warm up/warm down. Parking is free in the lot adjacent to the pool. Lockers are available at the pool for day use. Please no deck changing.
